Technical Advisor Report

A few weeks ago, we attended AMCA's Washington Conference. Once again, it was a productive and informative meeting. While walking from one Congressional meeting to the next, Jim and I had ample time to talk and one of the topics was membership and how valuable it was for AMCA members to have a presence in D.C. at this time. Jim reminded me that he wrote an article, years ago (2013 as it turns out) highlighting the importance of membership. I asked if he could find it. Of course, he did. So, I thought we could update it a bit and republish it for a new generation. What, perhaps, is most interesting is how little we had to update. The issues and importance of membership from years ago are still very much relevant today.

We were facing decreasing budgets, rising costs, and increasing regulations nearly 15 years ago and many of our programs are facing these exact same issues today as environmental groups attack our practices and legislators look to decrease governmental spending and taxing. For these reasons, it's a good time for those of us involved in mosquito control to reassess our involvement in state, regional and national organizations. For many of us there is ever increasing pressure to cut membership to these organizations from our budgets to save money. However, we should really take a moment to consider not only the benefits of membership, but also how it saves money and quite possibly our livelihoods – namely our mosquito control programs.

State Organizations: To many this will seem obvious, but the importance of active involvement in your state organization cannot be overstated. You and your colleagues in your state are all impacted by the exact same rules and regulations as well as the same permits, fees, and political pressures that must be dealt with each season. By working together on things such as Pesticide Discharge Management Plans, NPDES Annual Reports, impending legislation, etc, you not only save precious time and resources, but decrease the likelihood of making mistakes that could be even more costly. Standing as a strong cohesive group when dealing with state regulatory agencies also ensures that regulations are enforced evenly throughout the state, so no individual in the group is treated unfairly by a regulator.

Regional Organizations: The greatest benefit of membership in your larger regional association is information. Quarterly newsletters, spring workshops, and annual meetings are all great ways to stay informed on the regulatory and legislative front. The policies in surrounding states very often become issues in your state sooner rather than later. Operationally, these meetings are an excellent source of new and innovative methods for record keeping, larviciding, adulting, mapping, etc. The combined knowledge base of the group is also a tremendous resource. Having a large group who deal with diverse habitat and regulatory environments you can contact when seeking advice is worth far more than the small membership costs.

AMCA: Membership in the AMCA adds another, nationwide, layer of contacts when you need help finding a solution to a problem. With more than 1,200 members and a worldwide reach, it is very likely someone has faced a similar situation to the one you are trying to solve. The researchers and colleagues you meet at the annual meeting can be an excellent resource for protocols and support for your expanding program needs. Publications such as Wingbeats, the AMCA Journal and these quarterly newsletters keep you up on the latest research, products and legislation. "Members Only" access to parts of the AMCA's website also provides you with valuable tools to help you operate. The "Technical Advisor" Dan Markowski is available to give you information on specific topics or give you contact information of experts who can help you with specific questions. The AMCA annual meeting and webinars offer fantastic opportunities to learn directly from experts on a wide range of topics.

And back to the genesis of this discussion, the AMCA plays an active and significant role in legislative and regulatory matters that affect every one of our programs. All funds from sustaining memberships over the standard membership fee go to legislative advocacy. The AMCA is your only voice in Washington D.C. on the growing number of legislative and regulatory issues that affect our industry. Attending AMCA's Washington Conference and requests to send letters to your congressman provide you with a powerful voice in favor of mosquito control. Without representation in Washington, where would we be? If you're not at the table, then you're likely to be on the menu.

South Pacific Director Report

The 2026 season opened early and warm across much of the South Pacific Region. A mild winter and wet spring moved surveillance start dates forward in several states, and early-season mosquito abundance and West Nile virus (WNV) activity are running ahead of last year in parts of California, Nevada, and Arizona. Invasive *Aedes aegypti* continues to expand its range, and sterile- and incompatible-male release programs are scaling up region-wide. Travel-associated introductions of dengue and West Nile also remain a shared concern across the region, even where local transmission has not been detected. The summary below combines district reports from across the region with recent reporting from each state, covering activity from January through mid-June 2026.

CALIFORNIA

Coastal districts opened the year with their second annual Invasive *Aedes* Summit, setting *Aedes* control and surveillance plans for the season. Several Coastal districts plan to deploy the sterile insect technique (SIT) for the first time in infested parts of their counties, and voters in Santa Cruz and Santa Clara counties approved assessment increases. In Southern California, districts report higher-than-average abundance of both *Culex* and *Aedes*, which managers expect to translate into an active disease season; most are working with SIT in some capacity to evaluate how it integrates into their programs and what scaling would require.

In the Northern San Joaquin region, Turlock MAD is inspecting and treating Turlock Irrigation District electrical transformer vaults, roughly 3,000 of an estimated 30,000 vaults to start. Some vaults run eight feet deep and are entirely flooded, submerging electrical equipment, and have proven to be significant neighborhood breeding sources, particularly for *Aedes aegypti*. The district negotiated access under SB 1251 and plans to collect data and imagery to share guidance with other districts facing utility-vault breeding. Crews completed the necessary training and protective-equipment setup before entry, and each inspection requires opening a vault only enough to check for standing water. Turlock MAD is also expanding its MosquitoMate *Wolbachia* release footprint from 25 to 100 acres this year, growing the original Turlock plot to 50 acres and adding two 25-acre plots in Hughson and Denair. Across the model region, every participating district is now contracting with VDCI for aerial mosquito control, a first. San Joaquin MVCD is preparing to bring a new laboratory facility online.

In the Southern San Joaquin Valley, Delta MVCD and Fresno MVCD both report high early season counts of *Culex* and invasive *Aedes*. Consolidated MAD is seeking a formal agreement with PG&E for utility-vault inspections, echoing the access work underway to the north, and Tulare MAD is still awaiting FEMA

clearance for reimbursement tied to the 2023 winter storms. Fresno Westside MAD held a well-attended open house. Elsewhere in the valley, Westside MVCD is resealing its yard for safety and longevity, and a vendor recently approached Kern MVCD about using aerial photography to locate neglected green swimming pools.

West Nile virus arrived early statewide. The California Department of Public Health confirmed the first 2026 activity this spring through dead birds in San Diego, Alameda, and Santa Clara counties, and by early June at least nine counties had reported activity, with positive mosquito samples in Los Angeles, Orange, Fresno, and Riverside counties and no human cases yet. Fresno County's first detection came weeks earlier than in 2025, and the Coachella Valley MVCD reported an early-season positive in North Shore.

On the invasive front, *Aedes aegypti* has now been detected in more than two dozen of California's 58 counties with new spring finds including Boulder Creek in Santa Cruz County and additional sites in Contra Costa County. And in a development relevant to the region's SIT work, Verily's Debug program has applied to EPA for an Experimental Use Permit to release up to 32 million sterile *Wolbachia Aedes aegypti* males across California and Florida over two years; the application is under EPA review with a public comment period.

NEVADA

Per the Southern Nevada Health District (SNHD), 2026 surveillance in Clark County has set 1,030 traps and submitted 1,064 pools representing 23,385 mosquitoes; none have tested positive for WNV, SLEV, or WEEV to date. SNHD reported the season's first human WNV case in early June, a Clark County woman in her 40s with neuroinvasive illness who was hospitalized and has since recovered. No human cases were reported in 2025, following 26 in 2024.

Aedes aegypti, established in southern Nevada since 2017, now spans more than 60 ZIP codes, and mosquito counts this year are running more than double 2025, with roughly 92 percent of tested mosquitoes identified as *Culex quinquefasciatus*. SNHD began surveillance about a month early this year after the mild winter and wet spring, and UNLV's mosquito lab is studying whether WNV overwinters locally. Public complaints have climbed alongside the *Aedes aegypti* expansion, and the district's Fight the Bite outreach continues to stress draining standing water and using repellent.

ARIZONA

Arizona held its annual Vector Conference in April, hosted by Pima County. Alongside the state's monthly Arbo Calls, programs have begun hosting an informal series called the Bug Buzz to work through questions and challenges, aimed especially at groups new to vector surveillance and control. A separate 3D-print workshop covered building and modifying surveillance traps and tools; a few programs have started fabricating and repairing their own traps, and the session focused on the challenges of 3D printing for Arizona's harsh environment.

The arbovirus season started early. Without a significant frost across the southern part of the state, abundance of mosquitoes of medical importance was already significant in February. *Culex tarsalis* and *Culex quinquefasciatus* peaked in March and have persisted in many areas even as temperatures climb and recent rainfall stays light. *Aedes aegypti* started slower but rose sharply in the first two weeks of June. With lower precipitation, floodwater mosquitoes have stayed below average statewide, with significant catches in only a few areas.

Virus detections in mosquitoes have run high for this point in the season: 136 WNV-positive pools across five counties and 46 SLEV-positive pools in two counties as of June 12. SLEV pools peaked in April and declined through May, while WNV positives peaked in May and are still being added weekly into June. On the human side, Arizona has recorded 19 WNV cases, including two deaths, across three counties as of June 12, above expectations for this point in the year. May alone brought nine cases against a five-year (2021–2025) monthly median of one, an early surge that mirrors what surveillance is seeing in the mosquito population. Dengue, Zika, and chikungunya remain travel-associated in Arizona

rather than locally acquired, which keeps *Culex*-borne West Nile and St. Louis encephalitis the season's central public-health focus, and state and county programs are running public messaging to reinforce bite prevention.

HAWAII

The Hawai'i Department of Health has reported five travel-related dengue cases in 2026 to date, on Maui, O'ahu, and Kaua'i, all in returning travelers, with no evidence of local transmission. The DOH Vector Control Branch conducted inspections and mosquito reduction around each case, and recent Kona Low storms prompted renewed standing-water reminders. As a major travel destination with established *Aedes* populations, the state continues to lean on rapid case response and traveler awareness to keep introductions from taking hold.

Hawai'i's signature mosquito-control effort remains the “Birds, Not Mosquitoes” partnership, which uses the incompatible insect technique to suppress invasive *Culex* that spread avian malaria to native honeycreepers. More than 40 million *Wolbachia*-carrying males have been released across Maui and Kaua'i since late 2023, increasingly by drone, and EPA issued a *Wolbachia* release permit for the Hawai'i program this spring. The releases are intended to hold invasive mosquitoes below the high-elevation forests where the islands' last honeycreepers survive, a refuge that warming temperatures are steadily eroding.

IN CLOSING

Early, warm, and active is the theme so far, earlier surveillance starts, earlier West Nile detections, and rising *Aedes* abundance, set against the expanding use of sterile- and incompatible-male tools across the region. The growing exchange of methods across districts from utility-vault access to in-house trap fabrication to sterile- and incompatible-male releases has been one of the season's more encouraging threads. Thank you to everyone who contributed district updates for this report. Stay cool and safe through the summer, and I look forward to seeing many of you at the regional and statewide meetings ahead. ■



South Central Director Report

Summer has once again reared its ugly head in the South-Central region. With the rising temperatures and torrential rain comes the inevitable surge in mosquito activity, and for many of us, the worst it gets all year. Here is a look at where our region stands, a recap of our spring advocacy, and a preview of what's coming up soon.

ARBOVIRUS ACTIVITY

While the season is still unfolding, we are already tracking virus activity across several states:

- **Texas:** Reporting 67 mosquito samples positive for West Nile virus (WNV). Texas has also seen several imported, Aedes-associated human cases (dengue and chikungunya), alongside confirmed human WNV activity.
- **Louisiana:** Reporting nearly 20 WNV-positive mosquito samples.
- **Oklahoma:** No positive mosquito samples reported yet, though human WNV activity has been detected.
- **Mississippi & Arkansas:** Currently reporting zero mosquito virus activity.

TRAINING AND ADVOCACY

Multiple opportunities for training and recertification are happening all over the region!

- **LMCA Spring Workshop (April/May):** As always, the LMCA brought a great training program to its members. They also pivoted to an engaging, brand-new virtual format over weekly sessions rather than a classroom setting.
- **TMCA Spring Workshop (April 8–9):** Brought members together in San Antonio for an informative couple of days of learning and collaboration.

- **AMCA Washington Day (May 12):** Our region made a strong impression on the 27th annual march on the Hill. Representing the LMCA were AMCA Past President Herff Jones, President Dr. Isik Unlu, Dr. Claudia Riegel (Gulf South Vector), and Andrew Scherer. Representing TMCA, Nina Dacko even had the opportunity to meet directly with Senator Ted Cruz!

Advocacy: Our delegation had vital conversations with lawmakers to emphasize the critical importance of local mosquito control, the Kay Hagan Tick Act, the SMASH Act, and the direct benefits these initiatives bring to their constituents. *(A big thank you to Nina for providing this summary from the TMCA newsletter!)*

If you haven't yet attended Washington Day, it is an incredibly rewarding experience and worth prioritizing in the future. Advocacy and outreach are more vital now than ever. We are experiencing first-hand the urgent need to prove the importance of our work to constituents. If you don't know where to start with your planning, please reach out and I will be happy to help you!

Legislative and Regulatory Committees Update

AMCA had another successful Washington Conference in May. This meeting provides an opportunity to advocate at the federal level for critical issues that directly impact mosquito control programs on the ground. Your voice matters, and this meeting is a chance to see just how powerful our collective advocacy can be.

Angela Beehler, Washington Conference Chair, put together a fantastic educational agenda for the first day before members hit the Hill for meetings with their legislators. We were able to hear from federal agencies and Regional Centers for Excellences and Training and Evaluation Centers all over the country. Valuable information on research was provided, and discussions were had about how important funding is for these Centers to continue.

But the advocacy and relationships with your legislators don't end when we leave DC. There are local offices for your federal legislators just down the road from you and we encourage members to reach out and educate. Take the position papers created by AMCA and talk to the local office about the issues that are important to public health mosquito control right in your communities. <https://www.mosquito.org/action-center/>.

The AMCA Legislative and Regulatory Committee has been actively engaged in several significant initiatives, and many of these were position papers at the Washington Conference. Below are a few key highlights this quarter.

KAY HAGAN TICK REAUTHORIZATION ACT

We all know how important federal support is in the fight against vector-borne diseases. One of our top priorities was securing the [reauthorization of the Kay Hagan Tick Act \(S. 2398/ H.R. 4348\)](#). Whether through the Regional Centers of Excellence in Vector-Borne Disease or CDC grants, this bipartisan legislation helps fund the research, surveillance, and operational tools we need to protect communities from vector-borne disease.

So, what's in the reauthorization? Here are the highlights:

- *Keeps the National Public Health Strategy going* – ensuring HHS continues to update and implement a coordinated approach to vector-borne diseases.
- *Reauthorizes the Regional Centers of Excellence* – funding cutting-edge science, training, and surveillance for another five years (funding is set to expire this year!).
- *Extends CDC grants to state and local health departments* – supporting data collection, early detection, diagnosis, treatment, and public awareness efforts.

FUNDING PRIORITIES TO PROTECT AMERICA FROM MOSQUITO AND TICK-BORNE DISEASES.

ELC funding is critical for efforts related to the surveillance, detection, response, and prevention of infectious diseases, including VBD. In 2025, CDC's DVBD received requests for more than \$30 million from the state departments of health for VBD through the ELC program. However, the Division was only able to support \$17 million, a little more than half of the amount needed. The AMCA requests an additional \$10 million through ELC funding to continue and grow support and engagement with VectorSurv.

In mid-June, House Appropriations Committee marked up the Labor HHS FY'27 legislation. ELC is poised to receive a bump to \$55M from the prior flat-line level of \$40M. Advocacy on the House side from our membership should continue to focus on the underlying need for these funds with the added recognition and appreciation for the additional funds provided in the House bill.
